ORDER

WHEREAS, the Eastern Regional Committee, NCTE had granted recognition to Govt. College of Education, Burdwan, Kazirhat, P.O.-Lakurdi, Dist.-Burdwan, West Bengal-713102 (Code No. WB-S/E-4/89) for conducting B.Ed. Course of one year duration with an annual intake 65 students from the academic session 2000-2001 vide order No.F.ERC/7-14/2000/1570 dt. 19.07.2000.

- 2. AND WHEREAS, on the basis of implementation of NCTE's Regulation 2014, Revised Recognition Order (RRO) was issued for conducting B.Ed. course of two years duration with an intake of 50 (one basic unit) from the academic session 2015-2016 vide No. F.ERC/NCTE/WB-S/E-4/99/B.Ed. (Revised Order)/2015/32652 dt. 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 2. AND WHEREAS, ERC in its 280th meeting held on 29th February & 1st March, 2020 decided that recognition granted to B.Ed. course be withdrawn u/s 17(1) of NCTE Act, 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide No.ER-280.62/(WB-S/E-4/99)/B.Ed./2020/62584 dated 05.03.2020 to the institution on the grounds mentioned therein.
- 3. AND WHEREAS, the institution preferred an appeal at NCTE Hqrs. against the ERC's withdrawal order dated 05.03.2020. The Appellate Authority vide order No.89-162/E-185370/2021 Appeal/15th Meeting, 2021/100309 dated 30.06.2021 decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal orders (i) List of faculty, (ii) B.C.C. and (lii) Printout of Website. Appeal Committee further decided to remand back the case to ERC for revisiting the matter after the appellant institution submits the required documents.
- 4. AND WHEREAS, in compliance of appeal order, representation dt. 02.07.2021 submitted by the institution received on 11.01.2021. The ERC in its 295th meeting held on 21st August, 2021 after considering the original file along with other related documents. NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 30.06.2021 and Committee decided as under.

"Restoration of recognition order of B.Ed. course with an annual intake of 50 (one basic unit) be issued".
